

Terms and conditions:

- 1. The upper age limit for JRFs/JPFs is 28 years as on on 1/6//2025 (Relaxable by 5 years for SC/ST/Women/Physically Handicapped and OBC candidates).
- 2. Candidates should submit their bio-data in person, while attending the interview on 15th May 2025 from 9.30 AM to 10.30 AM. The registration process will be closed by the above specified time on the date of walk-in-interview.

3. The position is purely temporary and co-terminus with the project.

4. If at any time, in the opinion of the Director of the Institute you are found neglectful or unable to carry out research or guilty of conduct unbecoming of fellowship holder, the Director shall have the power to terminate your fellowship at any time without notice.

5. The position can also be terminated at any time by the Director without assigning any reason or earlier depending

on the performance of the candidates.
